

## Code of Conduct

While participating in all Virtual Camp UNITE on-line activities:

- Campers may not have in their possession, use or consume any tobacco products, electronic cigarettes, Juuls, non-prescribed or illegal drugs, or any alcoholic beverages.
- Campers may not be in possession of or use any weapons (knives, guns, etc.) or any explosive products.
- Campers shall not engage in the threat of, or commission of, any physical violence against any person.
- Campers shall not engage in verbal or written harassment or intimidation of any person by any means.
- Campers shall be fully clothed in appropriate apparel that does not contain designs or wording featuring foul language, alcohol/drug themes, or that is otherwise offensive.
- Campers shall not engage in any promiscuous, indecent, or obscene behaviors.
- Campers shall not use profanity or disrespectful language at any time.
- Campers should show respect for UNITE hosts, program providers, other adults, and campers at all times.
